Types of Cookies

Based on their purpose, cookies can be classified into different categories:

- **Essential and Technical Cookie:** These cookies are necessary for the basic functioning of the website. They allow users to navigate the site, use its main features, and ensure security.
- **Preference or Functional Cookie:** These cookies are used to remember user preferences, such as language or device display settings, to provide a more personalized experience.
- **Performance or Analytics Cookie:** These cookies are used to track user behavior on the website, collecting data such as pages visited and duration of visits to analyze and improve the user experience.
- **Advertising or Marketing Cookie:** These are used to track user activity across websites in order to display relevant and personalized ads. They may be used by companies to build a profile of your interests.

The types of cookies can be classified according to the entity that manages them into:

- **First-party cookies:** These are sent to the user's device from a computer or domain managed by the website itself.
- **Third-party cookies:** These are sent to the user's device from a computer or domain that is not managed by the visited website, but by another entity that processes the data obtained.

According to the length of time they remain active on the user's device, cookies can be classified into:

- **Session cookies:** These cookies are temporary and are automatically deleted when the user closes their web browser.
- **Persistent cookies:** These cookies remain on the user's device for a longer period, even after closing the browser, to remember preferences between visits.

You can configure your browser to notify you when cookies are sent, or you can choose to disable all cookies. However, please note that some parts of our website may not function correctly if you disable cookies.
